10.2 **To note WSCC's use of the furlough scheme** – noted

10.1 **Consideration of WSCC finances and forecast** – Councillors discussed the current situation and reaffirmed that as the business premises was owned by WWPC with a Public Works Loans Board financial commitment, it was in the public interest to support the business during the lockdown imposed by the government.

10.3 **Assessment of how much reserves the Council should keep as a bare minimum** – The insurance advises 50% of the precept but do not insist this. Due consideration was given to the Council's financial situation and to audit requirements.

10.4 **Assessment of how much could be afforded in assistance to WSCC.** The RFO confirmed that the Council's general reserves in the current year were adequate to allow financial assistance to be given.
