

Warwickshire Minerals Local Plan 2018-2032 Adoption Statement

19th July 2022

In accordance with Regulations 26 and 35 of The Town and Country Planning (Local Planning) (England) Regulations 2012 this Adoption Statement gives notice that Warwickshire County Council adopted the Warwickshire Minerals Local Plan 2018-2032 ("the Plan") and its Policies Map on 19th July 2022 as development plan documents.

The Plan was the subject of an independent online examination by an inspector appointed by the Secretary of State in October 2020. The Inspector's Report published in July 2022 confirmed that the Plan was sound, subject to a number of main modifications. The main modifications recommended by the Inspector together with additional (minor) modifications are included in the Plan. The Plan will supersede the saved policies in the Minerals Local Plan for Warwickshire 1995.

Any person aggrieved by the Plan may, with the leave of the High Court, make an application under Section 113(3) of the Planning and Compulsory Purchase Act 2004 on either or both of the following grounds:

- a. the Plan is not within the appropriate power;
- b. a procedural requirement has not been complied with.

An application for leave must be made to the High Court no later than the end of the period of six weeks beginning with the day after the date on which the Plan was adopted.

In accordance with the Regulations stated above, the following documents ("the Documents") have been made available:

- i. the Plan;
- ii. this Adoption Statement;
- iii. the Sustainability Appraisal Report (SUBs 03,04,05, and 06 PSDs 34,35, and 36).

The Documents can be viewed on the above website and downloaded free of charge. Copies will also be sent free of charge by email to anyone who requests them. Any person may request one paper copy to be sent by post at a cost of £75

The Documents will also be available for inspection in person at the County Council's Offices at Shire Hall in Warwick, and at all public libraries in Warwickshire. If you wish to inspect the documents at the principal offices of your local District Council/Borough Council, you may need to make an appointment. Further information on opening hours and visiting
