# 6. Confirmation of the minutes of the Council meetings

#### 7. Matters arising from the minutes not included in the agenda

7.1 Dead trees at Miller Homes enforcement – the Clerk had reported these to Stratford District Council planning enforcement.

#### 8. Open session for members of the public to raise any matters of relevance to the Parish

Mr Davies, The Mews, Wellesbourne House: Wellesbourne Lions' fundraising chairman. The Lions fund two defibrillators in the village (at the petrol station and the sports club) and wished to place a third in the Precinct area. They'd had some success in getting sponsorship and welcomed additional support from the Council. The Chairman said this would be addressed under item 12.3. Mr Hammond, Hammerton Way: had raised money for Friends of Hastings House by holding music gigs and asked whether Dog Close would be available to host future events. The Chairman said she would refer this to the Community Facilities Committee.

Mrs Dane, Newbold Road: updated the Councillors on the refurbishment of the Village Hall kitchen. The work was progressing well, although the lack of success in obtaining grants had meant a reduction in works done. Some old equipment had been sold to obtain funds. Extra work had been discovered where bricks had been previously removed to allow piping. This had cost £350. She brought this to the Council's attention as it was thought not to be the responsibility of the Village Hall Management Committee.

9.2 Cllr Parry – report noted. She had written to the Bishop of Coventry to reinforce support for protection of Wellesbourne allotments; the minor injuries unit at Stratford Hospital had re-opened; the recycling unit to replace the one destroyed by fire should be operational by next summer; there had been some delays in Biffa's subcontractors getting food caddies distributed but otherwise the changes to refuse collection had been smooth.

9.3 Cllr O'Donnell – report noted. She said that Warwickshire County Council's children's summer activity programme would include food for the children. There would be a webinar on 22<sup>nd</sup> August regarding Homes For Ukrainians, details available on WCC website.

#### 12. Highways, Environment & Emergency Committee

12.1 Committee Chairman's update – Cllr Blake said that Wellesbourne Speed Watch was working well, with many people receiving advice letters. Wellesbourne Flood Action Group continued its work and continued to work with other agencies to find ways to successfully reduce flood risk in the area. Concern regarding the upkeep of footpaths had been raised with Warwickshire County Council. Progress continued to be made with Safer Routes to School. Cllr Mrs Bolton raised concern about the reduced visibility on the A429 where trees obscured the lower street lighting due to the proximity to the airfield. Cllr Mrs Bolton reported that there was a dead tree in the front lawn of the flats in School Road.

## 13. Community Facilities Committee – Cllr AP

- 13.2 Newbold Road land planning application update The arboricultural survey had been completed and passed to the architect for submission to SDC.
- 13.3 SDC Community Infrastructure bid application update Cllr Mrs Prior confirmed this had been submitted. Bids had also been placed with SDC Shared Prosperity Fund
- 13.4 Green open spaces update The Council was still waiting for legal documentation for The Grange and Mountford Place. There has been much public debate about the future of Dog Close, especially on Facebook, regarding in particular the admission (or not) of dogs; Stratford Herald had also made enquiries. Many dog owners had expressed opinion that Dog Close should be open to dogs. Cllr Kendall suggested Cllr consideration that dogs might be permitted on leads. There was extensive debate amongst Cllrs. Cllr Howes suggested changing the name of the area to reflect its purpose e.g "Dene Nature Reserve"; Cllr Barton agreed and said any new name needed to reflect the land is a nature reserve. Cllr Kendall said that local people knew the area as Dog Close, and would call it that irrespective of its formal name. Cllr Blake said that it should be emphasised that it is a nature reserve, and there are other places in Wellesbourne to walk dogs. Cllr Dipple said it would be difficult to police people not walking their dogs in Dog Close, or indeed anywhere else. Cllr Mrs Prior said when the area was donated by Walton Estate, it was always intended that it would be an area of tranquillity. Cllr Kendall suggested that a public survey of more appropriate names might be beneficial. Cllr Mrs Prior proposed the issue be referred to the Community Facilities Committee agreed.

Cllr Mrs Prior said she would raise this in Wellesbourne and Walton News and on the Wellesbourne Parish Council Facebook page.
